Guardianship law reform

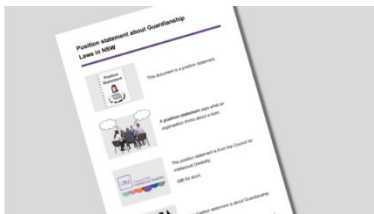


The My Rights Matter project thinks we need a new law so people with disability can get support to make their own decisions.

Our CEO Justine and Project Workers Ricky and Alex spoke to the Disability Royal Commission (DRC) about supported decision making.



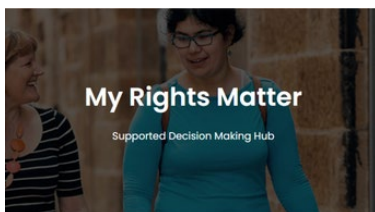
They told the DRC that all people have the right to decide and the right to support.

- training.

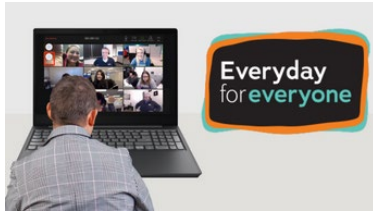

Learn how to lobby your local MP



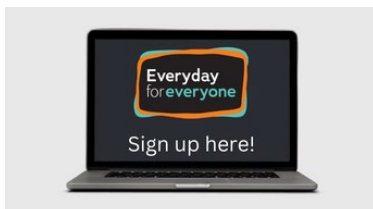
The Everyday for Everyone campaign is having 2 Zoom sessions.

They get together to:

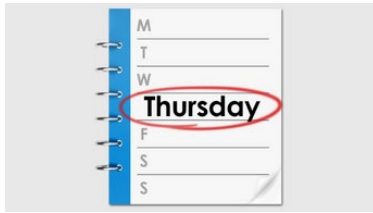
- share ideas

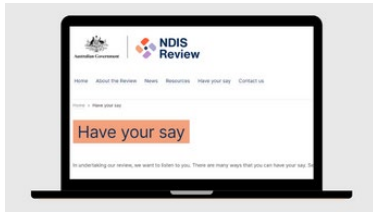
Have your say - NDIS Review

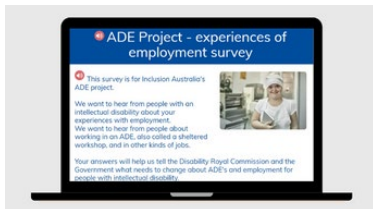
Job experiences – Inclusion Australia
