Dear Ms O'Neill,

I am writing on behalf of the NSW Liberals and Nationals to acknowledge your Everyday for Everyone Campaign, and to thank you for taking the time to make a contribution ahead of the NSW election. I also thank Jim and Ben for meeting with me earlier this year to discuss these important policy issues in person, and for your ongoing engagement with my staff.

We are sincerely grateful for your constructive engagement, because one of the core beliefs of a Perrottet Government is that embracing new ideas, not politics-as-usual, is the key to navigating the challenges ahead and securing our state's long-term success.

Your contribution has been taken into consideration to help shape our plan, and we hope to have the opportunity to engage further with you as we put our plan into action in the next term of government.

Thank you once again for your contribution and for your commitment to inclusion for all and helping the Liberal and Nationals Government build a positive future for NSW.
